The deadlines for submission of approval for those activities will be before this scholarship application deadline, to know who are presenting a poster (of their research) and who are doing a short talk (about their research). - Multifaceted mitochondria, Sitges, Spain, October 27-29, 2024; Apply by August 19, 2024
- Hallmarks of cancer, Guangzhou, China, November 7-9, 2024; Apply by August 30, 2024

The applicant must attend the meeting in-person and either present a poster presentation or short talk. The names will be selected randomly on the above mentioned dates from each Cell Symposia (listed above), and do a google random number generator to choose the winners during the Promotion

Period in accordance with these Official Rules. The recipient will verify their attendance in person when checking in at the registration desk. If the recipient does not attend the Symposia, the award will be offered to another recipient at a subsequent Symposia. The prize drawing will be conducted by Sponsor, whose decisions will be final and binding in all respects.

All winners are subject to proving eligibility to receive a prize.

Prizes:

Four (4) winners randomly selected will be given registration cost of Cell Symposium worth up to approximately \$900 USD each.
